

**Natural and Common Law Tribunal for Public Health and Justice**  
**Indictment and Trial**  
**Genocidal Technologies Pandemic**  
**Procedural Summary**

1. **Tribunal Sessions** - Both the Nov. 15, 2020 Hearing and Nov. 29, 2020 Trial are formal adjudicatory sessions of the Tribunal under Natural and Common Law, and each Judge will be functioning as a Tribunal Judge at each of these Proceedings.

2. **Indictment Issuance Session [Nov 15, 2020]** The functional purpose of the Nov 15, 2020 Session is to issue an Indictment so that it can be served via email upon known Defendants for the Trial. The Emergency Injunctions at Trial are intended to stop mass COVID vaccinations, any and all Vaccinations, mass COVID social control methods, masking, quarantines, lockdowns, concentration camps, and detention centers worldwide, stop 5G rollout COVID genocide, and stop the 2010-2020 Lockstep COVID-5G Co-Conspiracy that has been ongoing since at least 2010-2020.

After an Affirmation [like an Oath], the Tribunal will be presented with the Indictment and its probable cause evidence. Tribunal Judges can ask questions, suggest amendments and additions to the Indictment, and propose alternative probable cause evidence to be included in the Indictment. Once this phase of the Indictment Session is completed, the Tribunal votes and issues the Indictment, to be then served by publication, email, and other means on the known Defendants, who are called to Trial on Nov. 29, 2020. We are hoping to keep the Indictment Session, which will be recorded, to 3 hours maximum.

3. **Evidentiary Trial [November 29, 2020]** - The conduct of the Evidentiary Trial will depend on how many Defendants chose to appear and contest the Indictment. At the onset, Trial Judges can each present Evidentiary Statements or Briefs to the Tribunal that will become part of the Trial Record. Trial Judges and Witness Evidentiary Statements are due Friday, Nov. 27, 2020.

**Witnesses** - Trial Judges may also call upon Expert and Material Witnesses to give Evidence and present Evidentiary Documents at the Trial that will become part of the Record. Witness Evidentiary Statements are due Friday, Nov. 27, 2020.

Once the Trial Judge Evidentiary phase is completed, any Defendants present and their representatives may submit Evidentiary Statements and Briefs. Defendants' Evidentiary Statements are due Friday, Nov. 27, 2020.

There is a Recess while the Tribunal considers their Verdict and Judgment.

**4. Emergency Injunctions & Writ of Mandamus** - As you know, the Indictment seeks Emergency writs of Injunction to stop the Mass COVID Vaccinations, any and all Vaccinations, 5G rollout and activation, COVID Lockdown II and reported Concentration Camp phase of the 5G Genocidal Technologies Pandemic, as well as a Writ of Mandamus setting up a Reconciliation Commission that would direct Unjust Enrichment by Vaccination companies and other perpetrators [estimated in the hundreds of \$USD billions] into a Trust Fund for the benefit of the 5G Genocidal Technologies Pandemic, and of planet Earth.

The Tribunal's November 29, 2020 Verdict and Judgment can thus be taken for enforcement to the national courts of the 118 Nations Ratifying the International Criminal Court Statute<sup>1</sup> and other International, national, Police agency, common law, and *Lex Mercatoria* venues for enforcement.
