#3. *"Talking of Pharma Vaccine Dangers (which are known)*

#4. *" JUDGE DR. LEO REBELLO'S REFRAMED FINAL RESOLUTION FOR ADOPTION OF THE FULL HOUSE OF 28 JUDGES, UNANIMOUSLY*

Judge Dr. Leo Rebello of India moots that the present long-drawn, draconian LockDown be Lifted forthwith, being ab initio null and void, and another LockDown or Curfews should NOT be imposed. Similarly, Corona Vaccines should NOT be tested, tried or injected or NOT be made mandatory, as Nuremberg Code Article 6 Section 3 records: "No Govt can mandate medical treatment without individual or parental consent". The 28 Judges, therefore, unanimously aver, "We do not consent". And as such Vaccine promoters, producers, sellers and doctors are hereby forbidden to inject such deleterious vaccines.

All 28 Judges having unanimously passed this Resolution, Issue this Writ of Mandamus and exhort to the Presidents, Prime Ministers and the Supreme Courts, High Courts of various countries and the World Court to adhere and ensure this People's Verdict/Mandate is implemented with due diligence forthwith. Make no Mistake."
